



Application Checklist

Who qualifies for South Carolina Healthy Connections Kids?

Healthy Connections Kids provides medical coverage for uninsured children who meet the following requirements:

- ✓ Under 19 years of age
- ✓ Family income greater than 150% of and less than 200% of the Federal Poverty Level
- ✓ Family countable resources (cash, bank account, etc.) at or below \$30,000
- ✓ Uninsured for at least 3 months before qualifying, unless their coverage was involuntarily dropped
- ✓ Resident of South Carolina
- ✓ U.S. Citizen
- ✓ Have a Social Security Number or agree to apply for one
- ✓ Parents and legal guardians are not employed by the State of South Carolina

How do you apply for Healthy Connections Kids?

1. **Fill out and sign** the application.
2. **Get the papers and documents you need** for the application.
3. **Take it or mail it** to the nearest Medicaid office. You can find a list of the Medicaid offices on the other side of this page.

Citizenship documents

- If you are giving us proof of citizenship, take the original documents to your local Medicaid office with your application. **Do not mail original documents.**
- If you already gave proof of citizenship to the Medicaid office, mail the application with any other proofs to your local Medicaid office.

Send these papers with your application!

Use this checklist to make sure you have all the papers you need to apply.

- Copies of pay stubs for the last 4 weeks or a letter from your employer that shows your last 4 weeks of total pay.
- If you are self-employed, attach the most recent federal income tax form including all schedules.
- A copy of the letter telling you the total amount of any benefits you receive through Social Security, Unemployment, Veterans' Administration, or other sources, if any.
- Proof of all other income for the last 4 weeks, including child support (if any).
- A statement of what you pay or a receipt from a day care provider (child or adult day care)
- Proof of citizenship and identity (original documents). If you already gave this information, you don't have to give it again.
